1. The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through **ON-LINE** mode. The On-line registration of applications will be available on AIIMS Raipur website www.aiimsraipur.edu.in from **29/12/2016** (10:00 A.M.) to **28/01/2017** up-to 5:00 P.M.
2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfil all the eligibility criteria on or before **28/01/2017**, failing which their application will be rejected.
3. **Candidates should fill in the online application form, take a print out and must submit it along with self attested copy of all the relevant documents as mentioned below by Speed Post /Registered Post to Administrative Officer, AIIMS, Tatibandh, Raipur (C.G.) 4. For filling up of Online application, candidates must have the following pre-requisites ready :-

 - iv. Online payment detail of the required application fee.

Guidelines for scanning the photograph & Signature:

(ii) Signature:

- The applicant has to sign on white paper with Black ink pen.

- The signature must be signed only by the applicant and not by any other person.
- The signature will be used to put on the Hall Ticket and wherever necessary.
- If the Applicant's signature on the answer script, at the time of the examination, does not match the signature on the Hall Ticket, the applicant will be disqualified.
- Dimensions 140 x 60 pixels (preferred)
- Size of file should be between 10 kb – 20 kb
