**ADVERTISEMENT**

In accordance with the Corrigendum issued from the vishwavidyalaya vide No. No.Estt.-1/ File No.-01/2020/24 Dated: 15.04.2020 (available on VV website) and in continuation of previous Advertisement No.Estt.-1/ File No.-01/2020/4664 Dated: 14.11.2019, the post advertised earlier for the Assistant Professor in Vegetable Science (Academic level 10 Pre-revised Pay Scale Rs. 15,600-39,100 + AGP 6,000/-) under the economically weaker section (EWS) category is hereby re-advertised in **UR category** as per details given below. Online applications are invited from the interested applicants.

Note:

1. All the candidates applied previously under EWS category will be considered under UR category.
2. Those candidates who have already applied in EWS category are advised to apply again to take the benefits of updated qualification/experience if any. Such candidates will be exempted from paying the prescribed fee.
3. For those candidates, who have already applied in EWS category and not interested to apply again, their candidature and previous qualifications/ experience will be considered.

There will be no change in the number of posts and categories advertized earlier for the other subjects and in other categories i.e. under SC and OBC for vegetable science in particular. Web-link [igkvmis.cg.nic.in](http://igkvmis.cg.nic.in) will be opened for online application from 18/05/2020. Last Date for submission of online application form is 30/06/2020 upto 23:59 hrs.

**Qualification:**

**Essential**

1. Master's Degree in relevant subject of Agriculture/Agricultural Engineering/Veterinary faculty with at least 55% marks (or its equivalent grade 6.50 in 10.00 scales) with good academic record. Good academic records means Second class Master's Degree (55 % and above), Second class Bachelor's Degree (55 % and above). No third division in entire career from Higher Secondary onwards.
2. For the candidates having Master's degree, NET (National Eligibility Test) shall remain compulsory alongwith one publication in NAAS (National Academy of Agricultural Sciences, New Delhi) rated referred journal for recruitment to the post of Assistant Professor and equivalent in the disciplines in which NET is conducted by ICAR/UGC/CSIR.
3. Essentiality of NET can be waived off for the candidates holding Ph.D. degree provided, it has been done with course work as prescribed by the UGC Regulations 2009 and the candidate has atleast two full-length publications having a NAAS rating not less than 5 on the last date of submission of application. Candidates with Ph.D. degree without course work will not qualify for NET exemption.

The candidates registered for Ph.D. prior to July 11, 2009 shall be exempted from NET, subject to the conditions that:

- a) Ph.D. degree of the candidate awarded in regular mode only;\*
- b) Evaluation of the Ph.D. thesis by at least two external examiners;
- c) Open Ph.D. viva-voce of the candidate had been conducted;
- d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in refereed Journal;
- e) Candidate has made at least two presentations in conference/seminars, based on his/her Ph.D. work.
  - (a) To (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-chancellor/Dean (Academic Affairs)/Dean (University Instructions)"

\* "Ph.D. degrees which are pursued either full time or part time will be treated as degrees awarded through Regular Mode provided these are in conformity with the existing Statutes/Byelaws/Ordinances etc. of the degree awarding University. However, the Ph.D. acquired under distance mode is not permitted."

**Age Limit:-**

The applicant's age shall not be more than 35 years for the post of Assistant Professor. Upper age limit shall be determined as on the last date of submission of online application. Relaxation in upper age limit for ST, SC, OBC and women candidates (bonafide resident of Chhattisgarh only) will be provided as per C.G. Govt. Rules.

Note:-

- There will be no age bar for the employees/officers of the Indira Gandhi Krishi Vishwavidyalaya, Raipur working in regular services for the post of Assistant Professor/Scientist.
- The Permanent/temporary/contractual employees of government of Chhattisgarh or any undertaking of government of Chhattisgarh will be entitled for age relaxation as per government rules.
- As per the order of Govt. of Chhattisgarh, Department of General Administration, Mantralaya, Mahanadi Bhawan, Naya Raipur vide No. F 3-2/2015/1-3 Dated : 23.01.2017 the upper age limit for the bonafide resident of Chhattisgarh will be 40 years for all categories. However the age should not be above 45 years including all relaxations.

**GENERAL CONDITIONS:**

01.	Reservation for ST/SC/OBC candidates shall be available as per the Chhattisgarh Lok Seva (Anusuchit Jatiyon, Anusuchit Jan Jatiyon Aur Anya Pichhade Vargon ke Liye Arakshan) Sanshodhan Niyam 2011, 2012.
02.	30% reservation will be available for female applicant (bonafide resident of Chhattisgarh only) in each category as per C.G. Govt. Rules.
03.	6% reservation will be available for Person with Disabilities as per rules.
04.	Appointment to the post shall be temporary and the selected candidate will be kept on probation for two years and their service may be terminated if probation period is not completed successfully.
05.	Selected candidates will be posted at new Agriculture Colleges and will not be normally transferred before completion of probation period. Any type of request, influence or canvassing will not be considered.
06.	Application fee once paid shall not be refunded in any case.
07.	Applications not uploaded with copies of certificates, degrees, mark sheets/transcripts in support of academic qualifications and experience shall be rejected.
08.	Applicants must have achieved the requisite qualifications and experience on or before last date of application.
09.	Persons already in service must apply through proper channel. The candidate can take a print of filled online form for the purpose and send to the Registrar, IGKV, Raipur through proper channel by registered post <b>without enclosing any document/photocopy/reprints</b> . However to avoid delay, an advance online application alongwith requisite fees and other documents, may be submitted. Please tick appropriately on the online form "ADVANCE COPY". Such applicants must produce NO OBJECTION CERTIFICATE and NO ENQUIRY CERTIFICATE from their present employer at the time of interview.
10.	University has fixed a scorecard for recruitment on the post of Assistant Professor. Applicants are advised to fill the online application form carefully according to scorecard. The application without uploading proper certificates/marksheets/transcripts/documents/reprints will not be scored. In-service candidates must upload the experience certificate given by the employer to avail the marks allotted under experience.
11.	The applicants shall be required to present themselves before the selection committee, if called for interview, at their own expenses. ST/SC applicants will be allowed traveling allowance as per Vishwavidyalaya rules.
12.	Higher initial start may be granted to deserving applicants on the recommendation of selection committee.
13.	The candidate appointed to the post shall be governed by the <b>new pension scheme</b> introduced by State Government of Chhattisgarh and adopted by the Vishwavidyalaya.
14.	The Vishwavidyalaya reserves the right to increase/decrease or not to fill up any of the post, to fix criteria for calling the candidates for interview and/or not to call any of the applicants on account of sufficient reasons for interview. No appeal will be accepted/ entertained in this matter and Vishwavidyalaya's decision will be final.

If any information given by the candidate in above condition found incorrect, his/her appointment/selection shall be terminated without giving any notice.

01.	Only online application through web link <a href="http://igkvmis.cg.nic.in">igkvmis.cg.nic.in</a> shall be considered. Incomplete online application shall be rejected.
02.	Candidates should provide e-mail address and mobile number on which they want to receive communication. The candidates may be given directives/information/call letters etc. through university website and their e-mail only. However, the call letter shall be sent through registered post also. No other form of communication will be used in further course of action.
03.	The candidates are required to online submit/attach the photo copies of all documents, testimonials, certificates, reprints etc. with application. However, in case of publication, full texts need not to be attached. Attach only first page showing the necessary details of publication like title, author(s), date, year of publication and name of Journal/Publisher etc.
