4. Reservation for EWS will be as per Government of India Guidelines.

As per EWS guidelines posts are not carried forward/or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for post subjected to condition that they will be considered for the post as an UR Candidate only if EWS category seat is otherwise not filled.

GENERAL CONDITIONS

1. The aspiring applicants satisfying the eligibility criteria in all respects can submit their application only through **ON-LINE** mode. The On-line registration of applications will be available on AIIMS Raipur website www.aiimsraipur.edu.in from **20.08.2021 to 04.10.2021**.

2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfill all the eligibility criteria on or before **04.10.2021**, failing which their application will be rejected.

3. Candidates must fill in the online application form as per the procedure given in this Notice and take a printout of the same. 5. Candidates who wish to apply for more than one post should apply separately online for each post and pay the application fee for each post and submit hard copies separately for each post.

6. For filling up of Online application, candidates must have the following pre-requisites ready:-

- (ii) **Signature:**
 - The applicant has to sign on white paper with Black ink pen.
 - The signature must be signed only by the applicant and not by any other person.
 - The signature will be used to be put on the Hall Ticket and wherever necessary.
 - If the Applicant's signature on the answer script, at the time of the examination, does not match the signature on the Hall Ticket, the applicant will be disqualified.
 - Dimensions 140 x 60 pixels (preferred)

8. 9. **AGE LIMITS AND AGE RELAXATION**

- i) Professor/Additional Professor:** Not exceeding 58 (Fifty-Eight) years as on closing date of submission of online application form.
- ii) Associate Professor/Assistant Professor:** Not exceeding 50 (Fifty) years as on closing date of submission of online application form.

iii) **Age relaxation** permissible to various categories is as under:

(iv) No age relaxation would be available to SC/ST/OBC/PWBD candidates applying for unreserved vacancies.

NOTE : i) Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/ PwBD will be considered subject to Caste Certificate issued by the appropriate/ competent authority on the prescribed format. Community should be clearly and legibly mentioned in the certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidates will not be considered under any of the applied reserved category post(s).

Duly constituted Standing Selection Committee will conduct the selection process for all the posts.

12. OTHER CONDITIONS:

- ix) If at any time, in the opinion of competent authority, which is final in this matter, retired faculty consultant is found non-performing or guilty of any offence, dishonesty, disobedience, disorderly behavior, negligence, indiscipline, absence from duty without permission or any other conduct considered by the competent authority, deterrent to the interest of AIIMS or violation of one or more terms and conditions of this letter, his/her services may be terminated without notice and the competent authority shall be entitled to recover any damages arising out of any act or omission on his/her part, from him/her.
- x) Other conditions of service will be as provided under the Rules, Bye laws and Regulations of the Institute and governed by the relevant rules and orders issued by the Government of India. It may please noted that the retired faculty consultant will be required to conform to the Rules, Bye laws, Regulations, Discipline and Code of Conduct prevailing in the Institute from time to time.
